Ontario Council of University Libraries (OCUL) Ebooks License Agreement

THIS Electronic Products License Agreement (herein referred to as "LICENSE" IS AGREED the day of
BETWEEN
(herein referred to as "the Licensor")
and
Ontario Council of University Libraries, 130 St. George Street, Toronto, Ontario, M5S 1A5 (herein referred to as the "Consortium").

WHEREAS the Licensor holds the rights granted under this License,

AND WHEREAS the Licensee desires to enable Members of the Consortium to use the Licensed Materials and the Licensor desires to grant to the Consortium the license to use the Licensed Materials for the one-time Purchase Fee, subject to the terms and conditions of this License.

AND WHEREAS the Licensee has appointed the COU Holding Association Inc. to act as its Representative in administering the Business Terms of the License Agreement as defined in Schedule 1 on behalf of the Consortium and its Members,

IT IS AGREED AS FOLLOWS:

1. **DEFINITIONS**

In this License, the following terms shall have the following meanings:

1.1. <u>Authorized Users.</u>

Full and part time students, faculty and employees (including permanent, temporary, contract or visiting appointments) and researchers associated with the Licensee, regardless of the physical location of such persons. Walk-in Users shall be deemed to be Authorized Users under the terms and conditions of this License.

1.2. Commercial Use.

Use of the Licensed Materials for the purposes of monetary reward (whether by the Consortium, or Authorized Users or Walk-in Users) by means of sale, resale, loan, transfer, hire or other form of commerce. For the avoidance of doubt, the following uses shall not be deemed to constitute Commercial Use: recovery of direct costs by any Member of the Consortium from Authorized Users of the Licensed Materials in the course of research funded by a commercial organization; the payment of an administrative fee by a person in order to be registered with the Member as a Walk-in User; the recovery of copying costs as outlined in Section 3.5.

1.3. Course Packs.

A collection or compilation of materials (e.g. book chapters) assembled by staff of a Member for use by students in a class for the purposes of instruction.

1.4. Electronic Reserves.

Electronic copies of materials (e.g. book chapters) made and stored on the Secure Network by the Licensee for use by students who are Authorized Users in connection with specific courses of instruction offered by a Member to its students.

1.5. Purchase Fee.

The one-time payment set out in Schedule 1 for perpetual access to the Licensed Materials set forth on the initial Schedule 1 to this License. In the event additional Schedules of Licensed Materials are added to this License an additional Purchase Fee shall be payable by the Licensee as agreed by the parties. For the avoidance of doubt, the Purchase Fee shall be exclusive of any sales, use, value added or similar taxes and the Licensee shall be liable for any such taxes in addition to the Purchase Fee.

1.6. <u>Licensed Software.</u>

The software to be made available by Licensor as set out in Schedule 1 intended for use to search, view, retrieve, display, download, e-mail, and print any electronic item in the database of Licensed Materials, as may be modified from time to time.

1.7. Licensed Materials.

The electronic material as set out in Schedule 1 or in new Schedules to this License that may be agreed by the parties from time to time.

1.8. <u>Licensor's Representative.</u>

A third party appointed from time to time by the Licensor to act on the Licensor's behalf, with notice to the Licensee , who may execute this License on behalf of the Licensor and undertake any or all of the Licensor's obligations under this License, as agreed between the Licensor and the Licensor's Representative.

1.9. Licensee.

An institution who is a member of the Consortium and is a party to this License and who is bound to abide by the terms of this License for their institutions, employees, users and libraries.

1.10. <u>Licensee's Representative.</u>

A third party appointed by the Licensee to act on the Licensee's behalf, with notice to the Licensor, who may execute this License on behalf of the Licensee and undertake specific and defined portions of the Licensee's obligations under this License, as agreed to between the Licensee and the Licensee's Representative including, but not limited to, those parties listed below.

In this License, the COU Holding Association Inc. shall be authorized to execute and administer the Business Terms of the License Agreement as defined in Schedule 1 on behalf of the Licensee as Licensee's Representative.

Where Appendix 1 is appended to the License for the purposes of Local Archiving and Hosting of the Licensed Materials, the University of Toronto Libraries shall be authorized to execute and administer the provisions and terms of the Appendix on behalf of the Licensee.

1.11. <u>Member.</u>

An institution who is a member of the Consortium and is a party to this License and who is bound by the terms of a signed and authorized legal agreement with the Consortium to abide by the terms of this License.

1.12. Premises.

The physical premises of the Library or Libraries operated by the Members, as specified in Schedule 1.

1.13. <u>Secure Network.</u>

A network which is only accessible to Authorised Users by secure authentication.

1.14. <u>Server.</u>

The server, either the Licensor's server or a third party server designated by the Licensor, on which the Licensed Materials and associated access software are mounted and may be accessed.

1.15. Usage Data.

The data and reporting requirements specified in Section 6.11, which will be made accessible to the Licensee in a format acceptable to the Licensee.

1.16. Walk-in Users.

Individuals not affiliated with Licensee who are physically present at Licensee's site(s) as designated in Schedule 1 who are granted access to the Licensed Materials subject to the terms of this License.

2. GRANT OF LICENSE

2.1. General.

The Licensor has obtained the right to provide the Licensed Materials from the publishers of the materials contained in the databases.

Licensor hereby grants to the Licensee the nonexclusive and non-transferable right, to permit Authorized Users to access the Licensed Materials via a Secure Network and using the access methods specified in Schedule 1 for the purposes of personal research, teaching, private study, and administrative use associated with the normal practices and activities of the Licensee consistent with the fair dealing principles of Canadian copyright law and

comparable principles of international copyright law, subject to the terms and conditions of this License.

Except for the rights expressly granted under this License, all other rights are reserved to and shall remain the exclusive property of Licensor.

2.2. <u>Perpetual Access.</u>

Except for termination for cause (see Section 10.3), Licensor hereby grants to Licensee a nonexclusive, royalty-free, perpetual license to use the Licensed Materials that were accessible during the term of this License. Such use shall be in accordance with the provisions of this License, which provisions shall survive any termination of this License. For the purposes of clarity, inclusion of "Appendix 1 Local Archiving and Hosting of Licensed Materials" in the License Agreement shall constitute prior agreement to enforce all of the provisions of Section 2.2.

3. USAGE RIGHTS

Nothing in this License shall in any way limit the ability of the Licensee's Authorized Users to engage in or conduct any activity that would not constitute an infringement under Canadian or any other copyright laws, in respect of a copyrighted work.

The Licensed Materials may be used for the purposes of research, education, distance learning, or other non-commercial use as follows:

3.1. <u>Display.</u>

Members and Authorized Users shall have the right to electronically display the Licensed Materials.

3.2. <u>Digitally Copy.</u>

Members and Authorized Users may download and digitally copy a reasonable limited portion of the Licensed Materials.

3.3. Saving Copy

Members and Authorized Users may electronically save reasonable limited portions of the Licensed Materials.

3.4. Print Copy.

Members and Authorized Users may print a reasonable portion of the Licensed Materials.

3.5. Recovery of Copying Costs.

Members may charge a fee to cover costs of copying or printing portions of Licensed Materials for Authorized Users, including the costs associated with reproducing portions of the Licensed Materials for the creation of printed course packs. Such fees shall not constitute commercial use.

3.6. Course Packs/Electronic Reserve.

Members and Authorized Users may incorporate a reasonable portion of the Licensed Materials in printed Course Packs and Electronic Reserve collections for the use of Authorized Users in the course of instruction at a Member, but not for Commercial Use. Each such item shall carry appropriate acknowledgement of the source, listing title and author of the extract, title and author of the work, and the publisher. Course packs in non-electronic non-print perceptible form, such as audio or Braille, may also be offered to Authorized Users who, in the reasonable opinion of the Member, have physical or learning disabilities.

3.7. Electronic Learning Environments

Members and Authorized Users may incorporate limited parts of the Licensed Materials to be used in virtual and managed environments (including but not limited to virtual learning environments, managed learning environments, virtual research environments, library environments, and courseware technologies) hosted on a Secure Network. Each item shall carry appropriate acknowledgement of the source, listing title, author and copyright owner.

3.8. Use in Academic Research

Members and Authorized Users may incorporate limited parts of the Licensed Materials in printed or electronic form in assignments, portfolios, theses and dissertations, including reproductions of the Licensed Material for library deposit and other non-commercial uses.

3.9. Electronic Links.

The Licensor agrees to use reasonable efforts to comply with the Open URL standard. Licensee may provide electronic links to the Licensed Materials from Member's web page(s). The Licensor will assist the Licensee upon request in creating such links effectively, and will use the OpenURL standard for such links whenever feasible. Licensee may make changes in the appearance of such links and/or statements accompanying such links as reasonably requested by the Licensor.

3.10. Scholarly Sharing.

Authorized Users may transmit to a third party colleague in hard copy or electronically, reasonable amounts of the Licensed Materials for personal use or scholarly, educational, or scientific research or professional use but in no case for Commercial Use. In addition, Authorized Users have the right to use, with appropriate credit, figures, tables and excerpts from the Licensed Materials in Authorized User's own scientific, scholarly and educational works.

3.11. Interlibrary Loan.

Members shall be permitted to supply to an academic, research or other non-commercial library of a non-Member (whether by post, fax or secure transmission, using Ariel or its equivalent, whereby the electronic file is deleted immediately after printing), for the purposes of research or private study and not for Commercial Use, a single copy of an electronic original of an individual document being part of the Licensed Materials. Requests received from for-profit companies or directly from individuals may not be honored. Files

transmitted in this manner must carry copyright notices. Licensee agrees to fulfill interlibrary loan requests in compliance with Canadian Copyright Law.

3.12. Training and Marketing Materials.

Members may display, download or print the Licensed Materials for the purpose of internal marketing or testing or for training Authorized Users or groups of Authorized Users.

3.13. Caching.

Members and Authorized Users may make such local digital copies of the Licensed Materials as are necessary to ensure efficient use by Authorized Users by appropriate browser or other software.

3.14. Extraction from Databases.

If the Licensed Materials are a database, compilation or collection of information, Authorized Users shall be permitted to extract or use information contained therein for purposes such as educational, scientific, or research purposes, including extraction and manipulation of information for the purpose of illustration, explanation, example, comment, criticism, teaching, research or analysis, data mining for purposes of textual analysis and visual mapping of textual relationships.

3.15. Branding.

The Licensee or a Member of the Consortium may request that the product be branded with the name of the institution on the homepage of the product, or otherwise as agreed, in order to publicize the acquisition to the Authorized Users of the License.

3.16. Walk-In Users

Walk-In Users may be given access to the Licensed Materials by Licensee, but only: (i) from designated terminals, which are physically located in Licensee's premises; and (ii) with a Licensee controlled IP address.

3.17. <u>Indices.</u>

Members may use the Licensed Materials in connection with the preparation of or access to integrated indices to the Licensed Materials, including author, article, abstract and keyword indices.

3.18 Persons with Perceptual Disabilities

In regards to an authorized user with perceptual disabilities, the Member shall have the right to make a copy of the Licensed Materials in an alternate format in order to make it useable to this individual.

4. PROHIBITED USES

4.1. Unauthorized Use.

Licensee shall not knowingly permit anyone other than Authorized Users to use the Licensed Materials. Licensee may only use Licensed Materials as expressly permitted in Section 3 above. All other uses of the Licensed Materials are prohibited, including, but not limited to:

- (a) re-distribution, re-selling or sub-licensing in any manner including in connection with fee-for-service use or to other persons or entities except to Authorized Users (other than Walk-in Users);
- (b) supply or distribution of single or multiple copies in any form to anyone other than an Authorized User;
- (c) distribution of any part of the Licensed Materials on any electronic network, including without limitation, the Internet on the Worldwide Web, other than the Licensee's Secure Network; and
- (d) monetary reward (whether by Licensee or an Authorized User) by means of sale, transfer or other form of exploitation of the Licensed Materials or any part thereof without Licensor's prior explicit written permission. For the avoidance of doubt, bulk reproduction or distribution of electronic or print copies of Licensed Materials for sales/promotional purposes is specifically prohibited.

4.2. Modification of Licensed Materials.

Neither Licensee nor its Authorized Users may modify, adapt, transform, translate or create any derivative work in any medium based on or including any materials in the Licensed Materials, or otherwise use any such materials in a manner that would infringe the copyright or other proprietary rights therein. No copyright notices, trademark or proprietary notices, author attributions or other notices or disclaimers in the Licensed Materials included by Licensor, may be removed, obscured or modified in any way. Licensee shall post appropriate notices and take reasonable measures to ensure that Authorized Users are informed of the applicability of copyright law and have agreed to the restrictions in this License with respect to the reproduction, use and transmission of the Licensed Materials. In the event of violation of the terms and conditions of this License or of applicable copyright law, Licensor and Licensee agree to take immediate action to suspend access to the Licensed Materials by any Authorized User violating these restrictions on reproduction, use and transmission of the Licensed Materials and shall consider other restrictions on access to and retrieval of the Licensed Materials, including additional limitations on printing and downloading without prejudice to Licensor's rights and remedies.

4.3. Commercial Purposes.

Licensee may not use the Licensed Materials for any Commercial Use or for any purpose other than those outlined in Section 3.

4.4. Automatic Searches.

Licensee shall not use any robots, spiders, crawlers or other automated downloading programs or devices to continuously and automatically search, index or retrieve any content

accessed online under this License, except as permitted by this License. Licensee shall not reverse engineer, decompile or disassemble any software included in the Licensed Materials.

5. MUTUAL RESPONSIBILITIES

5.1. Confidentiality of User Data.

Licensor and the Licensee agree to maintain the confidentiality of any data relating to the usage of the Licensed Materials by Consortium and its Authorized Users. Such data may be used solely for purposes directly related to the Licensed Materials and may only be provided to third parties in aggregate form. Raw usage data, including but not limited to information relating to the identity of specific users and/or uses, shall not be provided to any third party.

5.2. Implementation of Developing Security Protocols.

Licensor and the Licensee shall cooperate in the implementation of security and control protocols and procedures as they are developed during the term of this License. Licensor reserves the right to monitor access to and use of the Licensed Materials to detect misuse of the Licensed Materials for the purpose of informing the Licensee.

6. LICENSOR RESPONSIBILITIES

6.1. <u>Availability of Licensed Materials.</u>

Upon the Effective Date of this License, Licensor shall make the Licensed Materials available to Licensee.

6.2. Support.

During the Term of this License, Licensor will offer Licensee and Authorized Users support through the Licensors Helpdesk (times to be added).

6.3. Quality of Service.

Licensor shall use reasonable efforts to ensure that the Licensor's server(s) have sufficient capacity and rate of connectivity to support the usage of the Licensee at a level commensurate with the standards of availability for information services of similar scope operating via the World Wide Web, as such standards evolve from time to time over the term of this License.

Licensor shall use reasonable efforts to make the Licensed Materials available to the Licensee at all times and on a twenty-four hour basis, save for routine maintenance (Licensor shall notify the Consortium in advance wherever possible), and to restore access to the Licensed Materials as soon as possible in the event of an interruption or suspension of the service. Scheduled down-time will be performed at a time designed to minimize inconvenience to Licensee with advance notice.

If the Licensed Materials fail to operate in conformance with the terms of this License, Licensee shall immediately notify Licensor, and Licensor shall promptly use reasonable efforts to restore access to the Licensed Materials as soon as possible. In the event that Licensor fails to repair the nonconformity in a reasonable time, Licensor shall reimburse Licensee in an amount proportional to the total Fees owed by Licensee under this

License. Persistent failure to comply with the provisions set forth in this License may be treated as a breach of the agreement as described in Section 10.3.

6.4. <u>Notice of Terms of "Click-Through" License Terms.</u>

In the event that Licensor requires Authorized Users to agree to terms relating to the use of the Licensed Materials before permitting Authorized Users to gain access to the Licensed Materials (commonly referred to as "click-through" licenses), Licensor shall provide Licensee with notice of and an opportunity to comment on such terms prior to their implementation. In no event shall the terms of such "click-through" licenses materially differ from the provisions of this License. In the event of any conflict between the terms of such "click-through" licenses and this License, the terms of this License shall prevail.

6.5. <u>Completeness of Content.</u>

Where applicable, Licensor shall use reasonable efforts to ensure that the online content is at least equivalent to print versions of the Licensed Materials, and represents a complete, faithful and timely replication of the print versions of such Licensed Materials where applicable. Licensor will cooperate with Licensee to identify and correct errors or omissions as required.

6.6. Portability.

The Licensee shall have the right to migrate the Licensed Materials on a locally hosted system to new formats, in response to technological change, in order to ensure ongoing access to Authorized Users, within the framework of this License. As per article 9.5, it is understood that digital rights management technology shall not interfere with this right.

6.7. Archiving.

Licensor recognizes the right, in the absence of an uncured breach by Licensee, of Licensee to possess the Licensed Materials as provided in this License, in perpetuity. Licensee (and its Authorized Users) shall have archival access to the Licensed Materials, (for so long as it is maintained by Licensor in its discretion) or through Licensee's own platform; provided, however, that Licensee shall observe all limitations imposed on Licensee under this License.

6.8. <u>Notification of Modifications of Licensed Materials.</u>

The Licensee understands that from time to time the Licensed Materials may be added to, modified, or deleted by the Licensor and/or that portions of the Licensed Materials may migrate to other formats. Licensor shall give a sixty (60) day notice of any such changes to the Licensee.

6.9. <u>Withdrawal of Licensed Materials.</u>

The Licensor reserves the right at any time to withdraw from the Licensed Materials any item or part of an item for which it no longer retains the right to publish and for which the Licensor has been unable to secure the provisions as set out in Section 6.10, or any item or part of an item for which the Licensor has reasonable grounds to believe it infringes copyright or is defamatory, or otherwise unlawful in nature from the Licensor's servers. The Licensor shall give written notice to the Licensee of such withdrawal. If the withdrawn material represents more than ten per cent (10%) of the Licensed Materials the Licensor

shall make a pro rata refund of part of the Fee to the Licensee, taking into account the amount of material withdrawn. Withdrawal of Licensed Materials from the Licensee's Servers shall be governed by the provisions set out in Appendix 1.

In the case where a request for permanent removal of Licensed Materials is made by the Licensor, the Licensee will remove the Licensed Materials from public access on the Licensee's platform and provide sufficient explanation as to the reasons for its removal.

6.10. Loss of Ownership of Licensed Materials.

In the event that ownership of a part or parts of the Licensed Materials is sold by the Licensor or otherwise transferred to a third party the Licensor will use all reasonable efforts to retain a non-exclusive copy of the volumes published and make them available free of charge through the Licensor's server.

6.11. Usage Data and Reports.

Licensor shall collect and compile Usage Data in accordance with the principles and guidelines established by the most current Project Counter Code of Practice (http://www.projectcounter.org/). Licensor will make reports available to Licensee on a regularized basis and in a format that render them useful to the Consortium and its Members, consistent with applicable privacy laws and written confidentiality requirements of the parties.

6.12. World Wide Web Consortium Standards

The Licensor agrees to make reasonable efforts to comply with the W3C standards as described at: http://www.w3.org/Consortium/.

6.13 MARC Records

Full OCLC-quality batched sets of MARC records will be provided at no additional cost. Updates to existing records and new titles records will be provided on a regular basis and in a format that render them useful to the consortia and its members.

7. CONSORTIUM'S AND MEMBERS' RESPONSIBILITIES

7.1. Provision of Notice of License Terms to Authorized Users.

Licensee shall make reasonable efforts to provide Authorized Users with appropriate notice of the terms and conditions under which access to the Licensed Materials is granted under this License including, in particular, any limitations on access or use of the Licensed Materials as set forth in this License.

7.2. <u>Provision of Notice of Intellectual Property Right to Authorized Users.</u>

Licensee shall make reasonable efforts to provide Authorized Users with notice of any applicable intellectual property or other rights related to the Licensed Materials. Licensee shall make reasonable efforts to prevent any infringement that comes to the attention of the Consortium or its Members, of any Intellectual Property or other rights of the Licensor in the

Licensed Materials. Licensee shall promptly notify Licensor of any infringement that arises, and take appropriate steps to avoid its recurrence.

7.3. <u>Protection from Unauthorized Use.</u>

Licensee shall use reasonable efforts to protect the Licensed Materials from any use that is not permitted under this License. Licensee shall use reasonable efforts to comply with the terms and conditions of this License by Authorized Users, and upon becoming aware of any unauthorized use or other breach, inform the Licensor in a timely manner and take reasonable and appropriate steps to ensure that such activity ceases and to prevent any future recurrence. Both parties agree to cooperate in good faith and provide sufficient exchange of information to prevent any further unauthorized use.

In the event of any substantial unauthorized use of the Licensed Materials by an Authorized User, (a) Licensor may terminate such Authorized User's access to the Licensed Materials, (b) Licensor may terminate the access of the Internet Protocol ("IP") address(es) from which such unauthorized use occurred limited to the specific IP address or subnet from which the use occurred, and/or (c) Consortium or its Member(s) shall terminate such Authorized User's access to the Licensed Materials upon Licensor's request. Licensor shall take none of the steps described in this paragraph without first providing written notice to both Consortium and relevant Member(s).

7.4. Maintaining Confidentiality of Access Passwords.

Where access to the Licensed Materials is to be controlled by use of passwords, Licensee shall issue log-on identification numbers and passwords to each Authorized User and use reasonable efforts to ensure that Authorized Users do not divulge their numbers and passwords to any third party.

8. REPRESENTATION, WARRANTIES AND INDEMNIFICATION

Subject to the Limitations set forth elsewhere in this License:

8.1. General.

Licensor warrants that it has the right to license the rights granted under this License to use Licensed Materials, that it has obtained any and all necessary permissions from third parties to license the Licensed Materials, and to the best of its knowledge that use of the Licensed Materials by Authorized Users in accordance with the terms of this License shall not infringe the copyright of any third party.

8.2. Physical Media.

Licensor warrants that the physical medium, if any, on which the Licensed Materials is provided to Licensee will be free from defects for a period of ninety (90) days from delivery, and may be returned if it is found to be defective.

8.3. <u>Limitations on Warranties.</u>

Neither party shall be liable for any indirect, special, incidental, punitive or consequential damages, including but not limited to loss of data, business interruption, or loss of profits, arising out of the use of or the inability to use the Licensed Materials.

Licensor makes no representation or warranty, and expressly disclaims any liability with respect to the content of any Licensed Materials, including but not limited to errors or omissions contained therein, libel, infringement of rights of publicity, privacy, trademark rights, moral rights, or the disclosure of confidential information.

Except for the express warranties stated herein, the Licensed Materials are provided on an "as is" basis, and LICENSOR DISCLAIMS ANY AND ALL OTHER WARRANTIES, CONDITIONS, OR REPRESENTATIONS (EXPRESS, IMPLIED, ORAL OR WRITTEN), RELATING TO THE LICENSED MATERIALS OR ANY PART THEREOF, INCLUDING, WITHOUT LIMITATION, ANY AND ALL IMPLIED WARRANTIES OF QUALITY, PERFORMANCE, MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. Licensor makes no warranties respecting any harm that may be caused by the transmission of a computer virus or other such malicious computer program. Licensor further expressly disclaims any warranty or representation to Authorized Users, or to any third party.

8.4. Indemnities.

Each party shall indemnify and hold the other harmless for any losses, claims, damages, awards, penalties, or injuries incurred by any third party, including reasonable attorney's fees, which arise from any alleged breach of such indemnifying party's representations and warranties made under this License, provided that the indemnifying party is promptly notified of any such claims. The indemnifying party shall have the sole right to defend such claims at its own expense. The other party shall provide, at the indemnifying party's expense, such assistance in investigating and defending such claims as the indemnifying party may reasonably request.

8.5. Term of Indemnity.

This indemnity shall survive the termination of this License for any reason. This indemnity shall not apply to any specific Licensed Materials if the Consortium or any of its Members has amended the Licensed Materials in any way not permitted by this License. The maximum liability of Licensor under this License, if any, for damages incurred by Licensee or any authorized user whether based in contract or tort, the total cost of the licensed product for the OCUL consortium, for the life of the agreement, as listed in Schedule 1. NO LIMITATION OF LIABILITY SET FORTH ELSEWHERE IN THIS LICENSE IS APPLICABLE TO THIS INDEMNIFICATION.

9. GENERAL

9.1. Entire License.

This License constitutes the entire agreement of the parties and supersedes all prior communications, understandings and agreements relating to the subject matter hereof, whether oral or written.

9.2. Amendment.

No modification or claimed waiver of any provision of this License shall be valid except by written amendment signed by authorized representatives of Licensor and Consortium and its Members.

9.3. Assignment & Transfer.

Licensee may assign this License without the prior written consent of Licensor. Licensor may assign this License without the prior written consent of Licensee. The rights and obligations of this License shall bind and benefit any successors or assigns of the parties.

9.4. Notices.

Any notices to be served on either of the parties by the other shall be sent by prepaid recorded delivery or registered post to the address of the addressee as set out in this License or to such other address as notified by either party to the other as its address for service of notices. All such notices shall be deemed to have been received within 14 days of posting.

9.5. Notice of the Use of Digital Rights Management Technology.

Neither party shall be liable in damages or have the right to terminate this License for any delay or default in performing hereunder if such delay or default is caused by conditions beyond its control including, but not limited to Acts of God, Government restrictions (including the denial or cancellation of any export or other necessary license), wars, terrorism, insurrections, strikes or other work stoppages, and/or any other cause beyond the reasonable control of the party whose performance is affected.

9.8. Severability.

The invalidity or unenforceability of any provision of this License shall not affect the continuation or enforceability of the remainder of this License.

9.9. Waiver of Contractual Right.

Either party's waiver, or failure to require performance by the other, of any provision of this License will not affect its full right to require such performance at any subsequent time, or be taken or held to be a waiver of the provision itself.

9.10. Governing Law.

This License shall be governed by and construed in accordance with the laws of the Province of Ontario and the parties irrevocably agree that any dispute arising out of or in connection with this License will be subject to and within the jurisdiction of the laws of Ontario and Canada applicable therein. Both parties agree that any action or proceeding relating to this License will be brought to a court of competent jurisdiction in the Province of Ontario, Canada.

9.11. Dispute Resolution.

If the parties disagree over an interpretation of this License or whether a party is in breach of any part of this License, the parties shall in good faith enter into negotiations to resolve the disagreement and discuss the feasibility of resolving the disagreement by mediation or other means short of litigation. The parties shall cooperate in good faith in pursuing mediation or such other means.

10. TERM AND TERMINATION

.

10.1. <u>Suspension of Access.</u>

The Licensor reserves the right to temporarily suspend any Member's access to the Licensed Materials for substantial infringement of the rights holder's intellectual property rights in the Licensed Materials or for a breach of the terms of this License that threatens either the performance or security of the Server. Any account suspension by Licensor shall comply with the provisions laid out in Section 7.3 of this License. Immediately after suspending such access the Licensor shall issue a notice to the Member and the Consortium of the breach specifying the activity of the Member that caused the breach. The Licensor shall forthwith restore access to the Member upon receipt of notice that such activity has ceased and that the Member has made reasonable efforts to protect against recurrence of such activity.

10.2. Breach of License.

In the event that either party believes that the other materially has breached any obligations under this License, or if the Licensor believes that the Licensee has exceeded the scope of this License, such party shall notify the breaching party in writing. The breaching party shall have 30 days from the receipt of notice to cure the alleged breach and to notify the nonbreaching party in writing that cure has been effected. If the breach is not cured within the 30-day time period, the non-breaching party shall have the right to terminate the License without further notice.

10.3. <u>Funding Contingency.</u>

If public funding of the Consortium or funding of the Consortium by the Members is materially reduced and the Consortium thereby becomes unable to pay future amounts payable pursuant to this License, the Consortium may give the Licensor written notice of termination and this License shall terminate effective 30 days after the giving of such notice if the Consortium has failed to pay the Fee for the calendar year in which such notice was given, or if the Consortium has paid the Fee for the calendar year in which such notice was given, January 1 of the following year.

As between the parties, all rights with respect to the publication titles, trademarks, logos, society names and colophons are expressly and exclusively reserved by Licensor.

NOW IT IS HEREBY AGREED as follows;

From the Date hereof the License Agreement shall be amended as follows;

1. General.

Licensor agrees to deliver electronic copies of the Licensed Materials to the Licensee for the purposes of loading onto its Server(s) and to provide access to its Members and Authorized Users (also known as 'local hosting'). Licensee hosting services are limited to those Servers within the Server Domain name of Scholarsportal.info and related IP address ranges.

2. <u>Format.</u>

In addition, Licensor agrees to provide Licensee with any other metadata information, including any DTD or XML Schemas, for the purposes of accurately loading, storing and rendering the Licensed Materials on the Server(s) operated by the Service Provider.

In addition Licensor agrees to Portability clause 6.6.

Licensor agrees to use reasonable efforts to assist the Licensee in all activities required to render a faithful reproduction of the Licensed Materials on the Licensee's servers, including making appropriately trained staff available during normal business hours for assistance (8:00 am to 4:00 pm EST).

The content of the Licensed Materials provided shall not normally materially differ from any equivalent print editions of books. Any exceptions shall be identified and agreed upon in advance by both Licensor and Licensee.

3. <u>Schedule of Delivery.</u>

Licensor agrees to make copies of the Licensed Materials available to the Licensee in a format consistent with this License within a reasonable time period.
